### Recent changes and more

The FSMA PSR add-on has been updated to version 1.3. There are 5 new control points added: three control points in the FSMA PSR add-on control points and compliance criteria (CPCC) related to the fruit and vegetables checklist based on IFA v5.2 and IFA 5.4-1, two control points related to the Quality Management System (QMS) checklist for producers registered for or certified to Option 1 multisite with QMS or Option 2, and additional changes to the CPCC, all available in Beta Audit Online Hub. The transition towards the LIVE and DEMO environments is expected on 7 September 2022. From 7 December 2022 and beyond, it is mandatory that all FSMA PSR add-on assessments are conducted against GLOBALG.A.P. FSMA PSR add-on v1.3
