Audit Online Hub: Recent changes and more

**Version 4.1.1** was transferred to the BETA environment (beta-audit.globalgap.org) on 4 December 2023.

Please note that we have recently introduced a new parameter through the API interface to facilitate site registration in the "Audit duration per day" section. This update is in line with the Farm Assurance Product included in the report for Smart audits. For more information, please refer to the <u>API</u> <u>Changelog</u>.

  - Group certification
- Residue Monitoring System (RMS) Standalone v6 (Smart audits (v6))
  - Included the "RMS Standalone v6" in our smart process for fruit and vegetables, combinable crops, tea, and hops along with the following reporting option:
    - Single site certification
  - Farm Sustainability Assessment (FSA) v3 standard (Smart audits (v6))
- Included the "Farm Sustainability Assessment v3 " standard in our smart process for the plants scope, along with the following reporting options:
  - Single site certification
  - Multisite without QMS
  - Multisite with QMS
  - Site of a multisite with QMS
  - Member of a group certification
  - Group certification
- Enabled a new flow to take the report backward in time by "Reviewers" and "Certification Committee" (Smart audits (v6)).
  - "Reviewers" or "CB committees" nominated in the report can change the status to "In progress" to allow Farm auditors/QMS auditors to rectify the audit report.
- Disabled the role "Farm auditor" from the Audit Personnel section when this is the only role assigned to the user and the audit report is being performed for a QMS (Group Certification or Multisite with QMS) (Smart audits (v6)).

## Configuration changes:

• The input of country of destination for the Coop Italia Pesticide Transparency v2 add-on reports was limited to "Italy" (Smart Audits (v6)).

## <u>Bug fixes:</u>

- Issue with the selection of the language through API for the Audit/GetPrinciples (v6) method has been resolved.
- Issue related to disabling editing data on closed audit reports has been resolved.
