Audit Online Hub

The following version will be transferred from the BETA environment (beta-audit.globalgap.org) to the LIVE (audit.globalgap.org) and DEMO (demo-audit.globalgap.org) environments on 03 September 2024.

Important note for API users

Kindly note that we have recently added a new optional parameter to the "Audit/List" and "Audit/Get" methods in the API interface. This parameter helps narrow down the search for audit data and applies only to Smart audits. For more information, please refer to the [API Changelog](#).

BETA AOH v4.8.1

Configuration changes:

- The following IFA v6 generic attributes have been updated:
 - From now on, the product registration in both site types "SITE" and "PHU/EXTERNAL_PHU" for any audit based on the reporting options "Single site certification", "Multisite without QMS", "Site of a multisite with QMS", and "Member of group certification" will determine the product selection in the following section:
 - "Products and activities observed during the audit"
 - From now on, the product registration in the "SITE" type site for any audit based on the reporting options "Multisite with QMS" and "Group certification" will determine the product selection in the following section:
 - "Scope verification"
- The Excel offline solution has been aligned with the user interface to sort P&Cs by content, irrespective of the standards and add-ons being audited.
- The sequence of the audit reports tabs has been updated to follow alphabetical order, from left to right, to initially display base standards.

Bug fixes:

- Issues that prevented users from deleting products have been resolved (Smart audits).
- Issues with duplicate content in the v5 PDF report have been solved.
- An issue with creating an audit copy when the GGN of the origin and destination were the same has been resolved (Smart audits).
- The flow that allows users with "Admin" access rights to reopen canceled audit reports has been fixed. This solution applies to all audit versions.
